<b>August 10, 2018 (E-88)</b>	Last day to consolidate with the General Election. Resolution pertaining to a measure must be to the Registrar of Voters by <b>August 10, 2018</b> . If you wish to have a full text printed in the sample ballot, the Registrar of Voters must have the full text by <b>August 10, 2018</b> . <span style="float: right;"><b>§ 10403</b></span>
<b>August 10, 2018 (E-88)*</b>	Last day for filing direct arguments, a city attorney impartial analysis and a fiscal impact statement (if applicable). If your Council passes a Resolution prior to <b>August 10, 2018</b> , adjust the date accordingly. <span style="float: right;"><b>§§ 9280, 9286</b></span>
<b>August 11, 2018 through August 20, 2018 (E-87 – 78)</b>	Public Review period for the measure text, impartial analysis, direct arguments, and fiscal impact statement, if applicable. Measure documents will be posted on the Registrar of Voters website. <span style="float: right;"><b>§§ 9190, 9295</b></span>
<b>August 13, 2018 (E-85)</b>	Registrar of Voters will email measure letter designations to cities that have measures on the ballot. <span style="float: right;"><b>§§ 13111, 13112</b></span>
<b>August 20, 2018 (E-78)</b>	Last day for filing of rebuttal arguments. If direct arguments are due prior to <b>August 10, 2018</b> , the rebuttals must be filed 10 days after the direct arguments. <span style="float: right;"><b>§ 9285</b></span>
<b>August 21, 2018 through August 30, 2018 (E-77 – 68)</b>	Public Review period for rebuttal arguments. All changes due to court action(s) must be finalized by <b>August 30, 2018, 5:00 p.m.</b> , to be included in the Registrar of Voters sample ballot pamphlet. <span style="float: right;"><b>§ 9295</b></span>
<b>September 27, 2018 (E-40)</b>	Sample ballot pamphlet mailing begins approximately this date. Mailing completed by <b>October 16, 2018</b> . <span style="float: right;"><b>§ 13303</b></span>
<b>October 5, 2018 (E-32)</b>	Polling places within your city will be available on the Elections Official Partnership website. <span style="float: right;"><b>§ 12286</b></span>
<b>October 8, 2018** (E-29)</b>	First day vote-by-mail ballots are available. All vote-by-mail ballots will be issued through the Registrar of Voters. If you receive requests at your City Hall, please forward to the Registrar of Voters. <span style="float: right;"><b>§ 3010, 3206</b></span>
