Lena:

Both the Friday email from Ms. Blair and an email this morning from the City Attorney to County Counsel requested immediate access to a report of the registered voters in Newport Beach, including which voters have signed up for the UOCAVA program for military and overseas voters.

We can provide a copy of the voter file pursuant to an allowable governmental use under Elections Code section 2194(a)(3).

This file of voters in Newport Beach would identify the voters signed up in the UOCAVA program and their preferred method of receiving their ballot. The special request voter file can be provided as a tab-delimited text document to allow the City to convert it into whatever format it needs. This file would not include the voters' driver's license numbers, social security numbers, signatures, or language preference.

There are two ways for the City to request this voter information from OCROV today:

1. If Ms. Blair requests the voter file, she must complete the attached Application for Voter Registration Information and submit it with a wet signature.
2. The City can request the voter file directly without an Application, pursuant to Elections Code section 2188(g)

The cost of a standard voter file is \$80.
