

**CALENDAR OF EVENTS FOR ORANGE COUNTY CITY MEASURES  
JUNE 2, 2026 STATEWIDE DIRECT PRIMARY ELECTION  
For City Clerk Use Only**

Shown below is a sequence of events, including statutory deadlines and Registrar of Voters' administrative deadlines, leading to the Statewide Direct Primary Election on June 2, 2026. This sequence shows the actions a City Council would need to take to place a city measure on the ballot.

The Registrar of Voters' recommended administrative deadlines will enable City Clerks to establish deadlines for the submittal of filings related to a measure, which provide a reasonable time to prepare the election material, the full 10-day public examination periods for the submitted filings, and sufficient time to resolve a petition for writ of mandate challenging any of the election materials without substantially interfering with the conduct of the election.

It is statutorily permissible for a City Council to order a city measure election up until 88 days before Election Day. If an election is ordered less than 109 days before Election Day, the Registrar of Voters would endeavor to conduct the election as ordered and would recommend the City Clerk set expedited filing deadlines for election materials. Even with such shortened deadlines, there would not be much time left for a court to resolve a legal challenge without impacting the conduct of the election.

All statutory references are to the Elections Code, unless stated otherwise.
