Declaration of Candidacy forms may be obtained in the office of the Registrar of Voters, 1300-C South Grand Avenue, Santa Ana, beginning July 13, 2026, and must be filed in that office no later than August 7, 2026, 5 p.m. To obtain additional Candidate Filing information, call the Orange County Registrar of Voters, Candidate and Voter Services Section, at (714) 567-7600 or access its website at ocvote.gov.

Appointment to each elective office will be made, as prescribed by California Elections Code Section 10515, in the event there are no nominees or an insufficient number of nominees for such office and a petition for an election is not filed within the time period prescribed by said Section 10515.

Notice is further given that starting Saturday, October 24, 2026, select Vote Centers will be open 10 a.m. to 6 p.m. Starting Saturday, October 31, 2026, all Vote Centers will be open from 10 a.m. to 6 p.m. On Election Day, November 3, 2026, all Vote Centers will be open from 7 a.m. to 8 p.m.

All ballots cast will be counted centrally at the Orange County Registrar of Voters' office, 1300-C South Grand Avenue, Santa Ana.

Notice is further given that Vote-By-Mail ballot processing will begin on October 5, 2026, and will continue Monday through Friday from 8 a.m. to 5 p.m. until the election is certified on or about December 3, 2026. The last day to request a replacement Vote-By-Mail ballot to be mailed is October 27, 2026. The Vote-By-Mail process is open to the public at the Orange County Registrar of Voters' office, 1300-C South Grand Avenue, Santa Ana.

Notice is further given that the Orange County Registrar of Voters will conduct a manual tally of specific precincts, and will begin on November 4, 2026, at the Orange County Registrar of Voters' office, 1300-C South Grand Avenue, Santa Ana.
